Minutes of the Regular Meeting of the Cape May County Library Commission held on Wednesday, January 18, 2023 at 1:30pm, in the Board Room of the Cape May County Library in Cape May Court House, NJ.

- 1. Mrs. Henderson called the meeting to order and announced it was being held in accordance with the Open Public Meetings Act.
- 2. The minutes of the meeting of December 15, 2022 were presented for review and approval. Mrs. Henderson made a motion to approve the minutes, which Mr. Ludgate seconded. The motion passed unanimously.
- 3. Orsini presented the bills for the month of January for review and approval for payment. Mrs. Henderson made a motion to approve the bills for payment, which Mr. Hutchinson seconded. The motion passed unanimously.
- 4. Under old business:
 - a. Orsini reported on the progress of the Cape May City Library at the Historic Franklin Street School project.
 - b. Orsini reported on the Lend-IT had been ordered for the Dennis Twp project, and D-Tech was also including a complementary Hold-IT machine for the project.
- 5. Under new business:
 - a. Orsini reported on the December 2022 programming statistics and noted a 40% increase from 2021.
 - b. Orsini reported that 2022 visitors were up 35%, circulation was up 13%, and computer use was up 25%.
 - c. Orsini reported that the 2023 tax rate was set at .00034.
 - d. Resolution January 2023 #1, Separations, was introduced. Mr. Mastrangelo made a motion to accept the resolution, which Mrs. Henderson seconded. The resolution passed unanimously.
 - e. Resolution January 2023 #2, Advancements, was introduced. Mrs. Henderson made a motion to accept the resolution, which Mr. Ludgate seconded. The resolution passed unanimously.
 - f. Resolution January 2023 #3, New Hires, was introduced. Mrs. Henderson made a motion to accept the resolution, which Mrs. Ponichtera seconded. The resolution passed unanimously.
 - g. Resolution January 2023 #4, LOAs, was introduced. Mrs. Henderson made a motion to accept the resolution, which Mr. Hutchinson seconded. The resolution passed unanimously.
 - h. Resolution January 2023 #5, RFPs, was introduced. Mrs. Ponichtera made a motion to accept the resolution, which Mr. Ludgate seconded. The resolution passed unanimously.
