- 1. Mrs. Henderson called the meeting to order and announced it was being held in accordance with the Open Public Meetings Act.

 - d. Orsini also reported that the Big Book Sale at the Court House Library will be 8/25-8/27.
 - e. Orsini reported that the Dennis Twp. lendIT Ribbon-Cutting is scheduled for 9/4 at 2pm.
 - f. Orsini also reported that the CMCL 100 Year Anniversary Celebration will be held on 9/20/25 at the Sea Isle City Library from 12-2pm.
 - g. Orsini reported that the Upper Cape Library sign was damaged and being replaced.
 - h. Orsini also reported that the Woodbine Library received some additional internet cabling, and the Children's area shelving was being replaced and rearranged.
